Payment and Tuition Information

Season tuition is divided into nine equal monthly installments (Tuition 1-9). Each installment is due on the 1st of the month according to the studio payment schedule and must be paid in full prior to the dancer's scheduled classes. Monthly tuition installments are calculated by averaging the total instructional season, rather than by the number of classes, days or weeks in any individual billing period. As a result, installments remain the same regardless of holidays, school breaks or whether a billing period contains more or fewer instructional days. If accounts are paid after the 5th of the month, there will be a \$10.00 late fee applied to the account balance as of the 6th. If tuition is not received by the 10th of the month, the dancer will be placed on probation and WILL NOT be allowed to attend class. All tuition payments will be charged 3.0% KPB (outside of city) sales tax, included within advertised rates. There is a \$25.00 returned check charge for any checks returned by the bank. Tuition installments are not prorated for absences, illnesses, vacations, holidays, school breaks or other missed classes. Dancer's tuition is expected to be paid in full, for the entire month, regardless of attendance. The applicable tuition installment due prior to Winter Break must be paid before the break begins. Families unable to commit to the full dance season and their nine monthly tuition installments are encouraged to register for eligible drop-in classes instead. Drop-In Class rate DOES NOT apply to Diamond Empire Squad dancers, nor may be utilized for prorating. Costume deposits are due at the time of registration. Enrollment in the season tuition program is a commitment to the full dance season, including participation in the annual concert and designated studio events, unless otherwise approved by Studio Directors. A \$30.00 drop-class fee will be billed, per class genre, if a dancer withdraws from the monthly installment tuition program one month prior to these annual performance dates. There are NO refunds or exchanges given for any reason, as classes are formulated by the registered students. I understand that if my child withdraws from the program, all fees and deposits are 100% non-refundable. Please review our studio policies. EVENT RETURN POLICY: NO Refunds or Exchanges. All Sales Final.
